

AN ORDINANCE FOR THE LEVY OF TAXES FOR THE CORPORATE PURPOSES OF
THE GLEN ELLYN MOSQUITO ABATEMENT DISTRICT FOR THE FICAL YEAR
BEGINNING AUGUST 1, 2014 AND ENDING JULY 31,2015

WHEREAS, the Board of Trustees [hereinafter referred to as the “Board”] of the Glen Ellyn Mosquito Abatement District, DuPage County, Illinois, [hereinafter referred to as the “District”] did on the 17th day of September, 2014, present at public hearing the annual Budget and Appropriation Ordinance for the District’s fiscal year beginning August 1, 2014 and ending July 31, 2015, the amount of which aggregates the sum of Two Hundred Eighty Six Thousand and Seven Hundred Dollars [\$286,700.00], which said Budget and Appropriation Ordinance was duly approved on September 17, 2014.

BE IT HEREBY ORDAINED BY THE BOARD OF SAID DISTRICT that there be and there is hereby levied on all the taxable property within the corporate limits of the District its fiscal year beginning August 1, 2014 and ending July 31, 2015:

This Ordinance shall take effect and be in full force from and after its passage and approval.
